If payments do not begin in June, 2025, the monthly payments will be calculated as the total tuition divided by the number of months remaining until May, 2026.

<b>FACTS Payment Plan Enrollment Fee:</b>		This one-time fee is paid electronically through FACTS once a payment plan is finalized by school. You will receive an email from FACTS notifying you of the agreement confirmation and upcoming fee payment.

<b>FACTS Peace of Mind Fee *OPTIONAL*</b>	\$ 22.50	This one-time fee is paid electronically through FACTS.

FACTS Peace of Mind Benefit ensures that if a family is unable to pay their tuition due to the death of the customer or the customer's legal spouse, the benefit may cover the student's tuition costs (coverage begins when the customer elects the peace of mind benefit and signs the FACTS payment plan agreement). This optional benefit will pay the remaining unpaid balance up to \$30,000 (except payments in arrears) on the agreement. This benefit is available to individuals who are under 70 at the time coverage begins. *This is non-refundable for any reason.*

<sup>d</sup> Consumable Fees are non-refundable for any reason. Should you choose to add these fees to your monthly tuition draft and withdraw for any reason after June 1, 2025, the balance of consumable fees are due in full.

- ❖ The requirements to receive a Parishioner Tuition Discount are set forth below and a list of all families claiming parishioner status is given to the church for confirmation of that status at least twice annually:
  - i. Be registered in the parish a minimum of six months. If transferring from another Catholic parish, written confirmation from one's previous parish needs to be supplied to the pastor of our parish that the family was active, known and in good standing.
  - ii. When in town, attend Mass faithfully every weekend and on Holy Days of Obligation. (At least 75% attendance) Attendance is recorded by use of envelopes and online giving.
  - iii. Be financially supportive of the parish. Saint Joseph Parish subsidizes each student at Saint Joseph Catholic School (SJCS) an average of \$500.00 per student.
  - iv. Be involved in parish activities, ministries, and programs.
- ❖ All SJCS families are required to complete and sign a Stewardship Agreement.
- ❖ All SJCS families are required to participate in the FACTS tuition management program. Tuition payment options are outlined on page 1 above.
- ❖ Prior to April 1, 2025, families can withdraw their enrollment at any time with no cancellation penalty. Any application or re-enrollment fees paid are non-refundable for any reason regardless of the date of withdrawal. Between April 1, 2025, and April 30, 2025, any family wishing to void their tuition contract will owe a contract cancellation penalty of \$1,000 per student. This amount is due in full by May 1, 2025. Beginning on May 1, 2025, if a student is withdrawn for any reason, remaining tuition, and consumable fees through the end of the academic year must be paid in full. Families interested in receiving a 1% discount must pay their tuition in full by May 31, 2025. Tuition Payments for the 2025 – 2026 academic year begin June 2025.
- ❖ If a student is asked to leave or withdraw from SJCS, the undersigned is responsible for the prorated annual tuition.
- ❖ Transcripts and records will not be released until the balance is paid in full with cash, certified check, money order, or confirmation of electronic payment through FACTS Family Portal.
