



2026 – 2027 Admissions Checklist:

- ✓ Online application form (required) – 2026-2027 - Application opens on Thursday, November 13th, 2025.
Complete and submit the online application. There is a \$175 application fee for the first application and \$30 for each additional application. K4 students must be 4 years of age on or before September 1, 2026. Application fees are non-refundable and are only good for the school year for which you are applying.
- ✓ Submit the following documents (if applicable) online during the application:
 - Copy of official state birth certificate
 - South Carolina certificate of immunization **(No religious exemptions per Diocesan policy. Medical exemptions must be approved by the Diocese.)**
 - Children enrolled in 4K-6th grade should present a South Carolina Certification of Immunization, DPH 4024, or, Military Certification of South Carolina School and Childcare Immunization Requirement, DPH 4375. Please see [link](#) for more information of acceptable certificates of immunization.
 - Prospective Student Evaluation Forms (K4-1st & 2nd-6th).
 - ★ This Prospective Student Evaluation forms must be completed by the current school your child is enrolled in and must be returned directly to our office for consideration for enrollment. It should not be given back to the parents for submission. Please find your copy [K4-1st](#) & [2nd-6th](#).
 - Most recent achievement test and report card (grades 2-6)
 - Copy of IEP or 504 plan, if applicable
- ✓ Admissions timeline:
 - 2026 – 2027 tuition rates will be posted online at www.stjosdevine.com on or before January 6, 2026.
 - Re-enrollment for current students ends on Friday, January 30, 2026.
 - Applications for new students will be reviewed, and acceptance emails will be sent by Wednesday, February 4, 2026.
 - Once the application is accepted, follow the instructions in the acceptance email to complete the online enrollment. There is no fee for online enrollment for new families. Students are not assigned to classes until the online enrollment process is complete and a payment plan has been created.
 - Once you receive your acceptance e-mail, you have 7 calendar days to complete the online enrollment process. If you do not complete the online enrollment process during that time, the application acceptance will be withdrawn should there be a wait list, and your child(ren) will be moved to the bottom of that list.
- ✓ Prior to April 1, 2026, families can withdraw their enrollment at any time with no cancellation penalty. Any application or re-enrollment fees paid are non-refundable for any reason regardless of the date of withdrawal. Between April 1, 2026, and April 30, 2026, any family wishing to void their tuition contract will owe a contract cancellation penalty of \$1,000 per student. This amount is due in full by May 1, 2026. Beginning on May 1, 2026, if a student is withdrawn for any reason, remaining tuition, and consumable fees through the end of the academic year must be paid in full. Families interested in receiving a 1% discount must pay their tuition in full by May 31, 2026. Tuition Payments for the 2026 – 2027 academic year begin June 2026.
- ✓ FACTS Financial Aid Application – deadline Monday, February 9, 2026
 - Once an application is accepted and online enrollment begins, you can apply for grant and aid through the FACTS Family Portal. From within the FACTS Family Portal, choose Financial on the left side menu bar and click “Apply for Grant & Aid” under Financial Links.
 - You will need the following documents to complete the application process:
 - 2025 W-2 forms
 - Copies of your most recent federal tax forms including all supporting tax schedules
 - Copies of supporting documentation for social security income, welfare, child support, food stamps, workers’ compensation, and TANF.
