^a To qualify for the 2026 - 2027 school year, the student must be a resident of South Carolina and have a household income that does not exceed 500% of the federal poverty guidelines. Visit <https://sc-estf-program.com/en> to pre-qualify and/or submit an application. If the family is awarded the scholarship, the Diocese of Charleston does require that 100% of the scholarship funds be utilized for tuition. This scholarship precedes any other tuition discount applicable. It is required that EVERY family who meets the income eligibility requirement submit an ESTF application in order to be eligible for any other financial assistance through the school or parish. Failure to submit an ESTF application will lower the calculated need for any need-based financial assistance through FACTS by the amount of the ESTF scholarship. Families are responsible for uploading quarterly invoices into Class Wallet. Failure to do so results in the family being held financially responsible for that quarter's ESTF funds. While the ESTF scholarship supersedes other discounts as a primary source of aid, families may still qualify for additional tuition discounts or school-based aid if their FACTS-determined financial need exceeds the \$7,634 ESTF award and the school is able to meet that remaining need. In such cases, eligible discounts may be applied to help bridge the gap. All aid decisions will be based on verified need and available resources, ensuring stewardship and equity in support of our families. **At no time will the school issue cash refunds for ESTF scholarships.** **Students can not receive both ESTF and Exceptional SC**

^b The Catholic Parishioner discount is awarded only to students whose families are practicing Catholics in good standing with Saint Joseph Catholic Parish. We will verify your status with the parish and they determine whether a family receives the discount. If a parish determines the family not to be in good standing, the discount will be reversed.

^c Tuition must be paid in full by the end of May 31, 2026, in order to receive the 1% discount. The 1% discount is calculated after all other application discounts have been applied.

^d To be eligible for the scholarship, students must be residents of SC, be eligible to attend a public school, and have a diagnosed disability (autism, deafness and hearing impairment, emotional disability, mental disability, orthopedic, other health impairment, specific learning disability, speech or language impairment, traumatic brain injury, visual impairment). Parents must apply directly through www.exceptionalsc.org. **Students can not receive both ESTF and Exceptional SC**

^e Through the incredible generosity of our extended community, the School and Parish offers several scholarship opportunities for returning students each year. A list of all funded and endowed scholarships is available at www.Stjosdevine.com.

^f A \$200 sibling discount will be applied for each additional student enrolled per family.

^g Saint Joseph Catholic School provides verified, need-based annual financial assistance to qualifying families. To request financial aid, please complete and submit your online application at <https://online.factsmgt.com/aid>. To receive financial aid, the application must be completed in its entirety and verified by FACTS Grant & Aid prior to the school's review and award of aid.

^h Re-enrollment fee will increase by \$100 after January 30, 2026.

ⁱ FACTS Peace of Mind Benefit ensures that if a family is unable to pay their tuition due to the death of the customer or the customer's legal spouse, the benefit may cover the student's tuition costs (coverage begins when the customer elects the peace of mind benefit and signs the FACTS payment plan agreement). This optional benefit will pay the remaining unpaid balance up to \$30,000 (except payments in arrears) on the agreement. This benefit is available to individuals who are under 70 at the time coverage begins. This is non-refundable for any reason.

^j Consumable Fees are non-refundable for any reason. Should you choose to add these fees to your monthly tuition draft and withdraw for any reason after June 1, 2026, the balance of consumable fees are due in full.

Tuition payments will be calculated based on the number of payments remaining until the end of May, 2027. Tuition is the base rate above, less any applicable discounts, divided by the number of remaining payments. Tuition payments are scheduled to begin in June 2026 and end in May 2027, allowing 12 months of payments. If payment does not begin in June 2026 due to late enrollment, the monthly or bi-monthly payment calculation will be higher due to less remaining payments being made. The school does not issue cash refunds for any surplus created by discounts or scholarships. If the total aid exceeds tuition and fees, no balance will be refunded to the family.
